## II. New Business

- a. Business meeting modality & scheduling
  - i. Discussion of whether we could stagger meeting times for the business meetings. They all end up meeting at the same time. For 2025 meetings will likely be spread out more across the conference (Thursdays/mornings/etc.)

- ii. There was discussion of allowing for virtual/online business meetings, but that would require a constitutional amendment. R&PA discusses:
  - 1. One opinion (drawing from NCA), is that some business meeting activities require in-person meetings, but other parts of association membership (like voting), could be done online to allow for a larger participation in the processes.
  - 2. Another note from the Constitution Committee is that the organization provides a time for every division, but that doesn't mean that the business meeting must occur or that it must occur at the conference
  - **3.** Some organizations give awards at business meetings and could shift that to panels.
  - **4.** Some divisions cut the meetings to 45 minutes so that there could be two meetings in a time block
  - **5.** Another concern is that dispersing business meetings across the schedule will cause conflicts with/between panels and meetings.
- **b.** Division merger discussion:
  - i. R&PA was approached by the American Society for the History of Rhetoric and Philosophy and Ethics of Communication to propose merging their two interest groups with us. Discussion:
    - 1. One member asked what problem would be solved by their joining our group, and whether the merger would result in the dissolution of the interest groups or whether we would need to cover all content
    - 2. We would not change our name
    - 3. Question of how many members are in ASHR & PEC
      - a. PEC 99 members
      - **b.** ASHR 169 members
    - 4. Discussion of how both organizations are part of RSA
    - **5.** Note that interest groups get fewer slots than divisions and that division size determines number of program slots
    - **6.** R&PA has 18 slots and used 12 this year.
    - 7. Suggestion that we tell each group that we could promise merged panels every year.
    - **8.** Suggestion that representatives from each group meets to discuss possibilities
    - **9.** Reminder to consider bylaws and rules for each group and to find more information before making a decision
    - Group decides that incoming vice chair (Baugh-Harris) will conversations with leadership from ASHR & PEC to explore possibilities of cooperative ventures.
