a. What is the status of Freedom of Speech division? They have dropped beneath the threshold of membership numbers, similar to Language & Social Interaction (LSI) Interest Group.

A: an email has been sent to leadership noting the problem with an April deadline. No response yet. The Constitution lists divisions requirements (Div member #s as % of general membership) but does not show how to move beyond if their #s are low. Concern with ignoring the constitution (KD-B) balanced by extending grace and not "running off" members (JH). Target of 20% of current membership (581-KD-B) would be 20 members to maintain Division standing. LSI was a Division but dropped to an Interest Group because of member #s not meeting the constitutional division member threshold.

- b. Everyone is having trouble with membership
  - 1. Only \$5 to join new divisions
  - 2. Concern that as we add new divisions (AACD as an example), numbers continue to be a problem, so John Haas thinks we give grace
  - 3. Jerry Hale suggests multiple solutions such as a constitutional amendment to lower #s or % needed. Decrease requirements or "thin herd."
  - 4. John Haas suggests that Strategic Plan might address this issue
  - 5. We are a volunteer service organization but we are lowering out numbers when we are already tapped. It's okay to be an Interest Group rather than a Division.
- c. Invoicing for extra \$5 to join new AACP: A: create an ad hoc invoice. Question on how to add more than 2 divisions (Webmaster to look into this)
- d. Other regional conferences are popular when scholarship is tied to that region. When scholars move, they don't join regional associations

Comment/Question: Laurie Metcalf noted that institutions don't typically pay for faculty memberships. As cheap to come to conference as a non-member, so can we package membership under an Institutional tier to incentivize joining?

A: John Haas noted many institutions will not pay for membership but will pay for fees.

## Note A - Nature of Activities and Significant Accounting Policies

## **Nature of Activities**

Southern States Communication Association (the Association) is a nonprofit organization that promotes the study, criticism, research, teaching, and application of the artistic, humanistic, and scientific principles of communication. It exists for educational, scientific, and literary purposes only. Southern States Communication Association began activities May 2, 1930.

## **Cash Basis of Accounting**

The Association's policy is to prepare its financial statements on the cash basis of accounting; consequently, revenues are recognized when received rather than when promised or earned, and expenses are recognized when paid rather than when the obligation is incurred. Accordingly, the accompanying financial statements are not intended to present financial position and activities in conformity with generally accepted accounting principles.

## **Cash and Cash Equivalents**

The Association considers all highly liquid investments available for current use with an initial maturity of three months or less to be cash equivalents.

Income Taxes

The Association is a not-for-profit organization that is exempt from income taxes under Section 501(c)(3) of the Internal Revenue Code and classified by the Internal Revenue Service as other than a private foundation.

The Association's Forms 990, Return of Organization Exempt from Income Tax, for the years ended July 31, 2021, 2022, and 2023 are subject to examination by the IRS, generally for three years after they were filed.

## **Date of Management's Review**

Management has evaluated subsequent events through March 15, 2024, the date on which the financial statements were available to be used.

## Note B - Concentrations of Credit Risk

The Association maintains cash balances at two financial institutions. Accounts at each institution are insured by the Federal Deposit Insurance Corporation (FDIC) up to \$250,000. The Association had no

uninsured cash balances as of July 31, 2023 and 2022.
