

INDEPENDENT ACCOUNTANTS' REVIEW REPORT

To the Board of Directors

Southern States Communication Association

Note A - Nature of Activities and Significant Accounting Policies

Nature of Activities

Southern States Communication Association (the Association) is a nonprofit organization that promotes the study, criticism, research, teaching, and application of the artistic, humanistic, and scientific principles of communication. It exists for educational, scientific, and literary purposes only. Southern States Communication Association began activities May 2, 1930.

Cash Basis of Accounting

The Association's policy is to prepare its financial statements on the cash basis of accounting; consequently, revenues are recognized when received rather than when promised or earned, and expenses are recognized when paid rather than when the obligation is incurred. Accordingly, the accompanying financial statements are not intended to present financial position and activities in conformity with generally accepted accounting principles.

Cash and Cash Equivalents

The Association considers all highly liquid investments available for current use with an initial maturity of three months or less to be cash equivalents.

Income Taxes



The Association is a not-for-profit organization that is exempt from income taxes under Section 501(c)(3) of the Internal Revenue Code and classified by the Internal Revenue Service as other than a private foundation.

The Association's Forms 990, Return of Organization Exempt from Income Tax, for the years ended July 31, 2022, 2023, and 2024 are subject to examination by the IRS, generally for three years after they were filed.

Date of Management's Review

Management has evaluated subsequent events through February 7, 2025, the date on which the financial statements were available to be used.

Note B – Concentrations of Credit Risk

The Association maintains cash balances at two financial institutions. Accounts at each institution are insured by the Federal Deposit Insurance Corporation (FDIC) up to \$250,000. The Association had no uninsured cash balances as of July 31, 2024 and 2023.

Nelson noted that the Constitution Committee had discussed possible amendments to the Constitution regarding the submission process for resolutions that would be brought before the membership. The committee recommendations will be presented at the business meeting.



6.3 Diversity, Equity, and Inclusion – Mary Meares and Xioti Fan

Mary Meares reported on the workshop sponsored by the DEI Committee. She discussed the legal and political issues surrounding DEI. She expressed concerns for the protection of individuals serving in DEI-related roles. An extended discussion regarding those concerns followed. A final reminder was also shared by Meares regarding the Diversity Keynote speaker.

6.4 Finance – Leslie Pace

The Finance Committee includes Nakia Welch, who will serve as chair next year, new member Eletra Gilchrist-Petty, and myself serving as committee chair. The committee met via Zoom on October 9th to discuss the mid-year report and used email to discuss Executive Director John Haas's proposal on March 11th.

John gave committee members read-only access to SSCA financial accounts fall 2024 to assure greater transparency, and the committee has continued to monitor transactions since being given access. SSCA currently has the following financial resources available.

Truist Accounts:

- Checking Account: Mid-year (Nov.) Balance \$160,086.87; Current (Mar.) Balance \$191,546.04
- CD Available Balance: \$54,675.53

UT Federal Credit Union: CD Available Balance -- \$189,017.65

John contacted me in March to discuss a proposal to begin paying a \$10,000 stiped to SSCA's Executive Director. The stipend could be used to buy out a course, to hire support staff, to take as salary, etc. Of note are the following:

- SSCA is the only regional organization that does not already provide a stipend
- the ED spends 40+ hours per week working on SSCA items/tasks
- it has been increasingly difficult to find people who are willing and able to hold the position
- the organization has been financially pragmatic and uses very little discretionary spending the organization's money is used primarily for bills, conference expenses, insurance for officers, and accountant fees.



Overall, the committee supports providing a stipend for the ED, and given current available balances, it appears it would cause no hardship to the organization or its members. The committee offers the following for consideration:

- The amount of work being done without supplemental income is significant.
- Making clear the ways the funds can be used is highly desirable.
- Would this create a slippery slope with other positions expecting a stipend?
- How does a stipend change the nature of a volunteer position that is designed to provide service to the discipline?
- How would the stipend be funded? Would membership fees need to be increased? If so, how much would fees need to increase?
- When was the last registration/membership fee increase? How much was that increase?

The Intercultural Communication Division of SSCA will host six panels this year. We received a total of 10 submissions (9 competitive papers, 1 paper panel). We accepted all of the submissions giving us a 100% acceptance rate on individual papers and discussion panels. From the paper submissions, three panels were formed including the Division's top paper panel. The program planner received permission to propose two additional roundtable panels which brings the Division's programming to six panels plus our annual business meeting.

This year's ICD programming offers rich and nuanced inter/cultural perspectives. Roughly 40% of the submissions stress an international, transnational, or global communication focus which exceeds the data from 2020-2026 where only 31% of the submissions centered on international foci. This trend among others, including centering the voices of marginalized cultural communities, contribute to the resilience and vibrancy of the ICD.

ICD's top paper award goes to Benjamin Bates and Cora Farra of Ohio University won for "Painting murals to define a "successful childhood": An application of a culture-centered, art-based approach in rural Ecuador."

Finally, the ICD elected officials met in March to explore strategies to increase paper submissions, collaboration with other divisions, and the potential for an increased social media presence for the Division. In addition, we discussed potential changes to the division's bylaws, the creation of a newsletter, and the need for more aggressive marketing for next year's conference.
