- 1. President Monette Callaway called the meeting to order at 11:09a.
- 2. President Callaway then welcomed the EC to Orlando.
- 3. Minutes were approved as amended.
- 4. The agenda was approved with amendment deleting item 8.1.
- 5.1 President Callaway reported on the formation of an ad hoc committee that will review our procedures and standards for federal compliance for non-for-profit entities. The members are Dick Ranta, Chuck Tardy, Tom Socha, Carl Cates, and Mike Osborn.
- 5.2 Vice-President John Meyer reported on plans for the 83rd convention in Louisville, Kentucky, April 10-14, 2013. He noted three panels and speakers of special interest: a past-president's panel, sessions focusing on the work of Richard Vatz, and the keynote of Michael Kramer.

- 5.5 Executive Director Carl Cates discussed the new website. Dr. Cates noted that the balances in the accounts and the profit & loss statements were normal for the time of year. Balances will increase with an increase in registrations. Dr. Cates also reported that the financial review was passed with no questions from the accountant. The membership report was noted as problematic.
