9. ANNOUNCEMENTS AND ADJOURNMENT

- 1. President John Meyer called the meeting to order at 8:12 p.m.
- 2. President Meyer welcomed members to the meeting. See attached roster for attendees.
- 3. Approval of the minutes: Approved without changes.
- 4. Approval of the agenda: Approved without changes.
- 5. Officer Reports:
- 5.1 President John Meyer: Dr. Meyer noted that he had contacted all committees including award committees charging each with its task. .
- 5.2 Vice-President John Haas: Dr. Haas noted a heavy load of submission. The program is in editing posting at a date soon. After thanking his planners he noted the inclusion of 200 panels, thanked his planners, noted program highlights and that so far 800 people were listed in the program.
- 5.3 Immediate Past President & Nominating Committee Monette Callaway: Ms. Callaway announced the election slate of Dr. Roseann Mandziuk and Dr. Mike Eaves for Vice-President Elect and of Ramona Clower and Brad Bailey for community college representative to the NCA Legislative Council.
- 5.4 Vice-President Elect Jean DeHart: Dr. DeHart noted the deadline for CUHC is December 15. She then discussed the call for 2015, Communication as Art and Craft.
- 5.5 Executive Director Carl Cates: Dr. Cates noted that registration for the convention was available and that hotel registration was open. He expressed concern that the hotel had informed the group that the World Wrestling Entertainment group has scheduled Wrestlemania for the same week as the convention. The hotel has no desire to increase the block and hotels in the area have no interest in booking overflow. The financial review from John Harvard showed no items of concern. The balances and profit-loss statement are normal for this time of the year. A manual review of the member list is being undertaken to see why we have fewer members. Also of concern is the low percentage of some divisions and interest groups. The staff will make contacts with those not expressing preferences.

The type of doctoral institutional programs on the website and under consideration for inclusion received a robust discussion. It was proposed that a list of programs be included in the SSCA website.

- 8.1 Amending the constitution to provide for the Suzy Osborn Community College Award Noted as having been done as committee report.
- 8.2 A new SSCA Mentorship Award
 - Dr. Meyer introduced the proposal for a new award for mentorship named for James D. Ragsdale. Discussion included amendment that the award must be funded at the \$10,000 level. Approved without dissent.
- 8.3 Incorporation and affiliation with NCA
 - The EC undertook a vigorous discussion regarding the requirement of NCA that all regionals apply for affiliate status. Incorporation is one of those requirements. Executive Director Carl Cates has located an attorney that can help investigate the process since SSCA is not incorporated. If able, the plan is to create an incorporated entity then merge SSCA into it so that we do not lose our history as an association. A budget amendment was presented to fund the process.
- 8.4 Approval of Jerry Hale as Executive Director-Elect pending ratification of membership Dr. Hale was approved with ringing endorsements.
